# Explanatory Notes

Council aims to ensure that fees and charges for goods and services are equitable. Fees are substantially based on a user pays principal; however there is recognition of people's ability to pay where community service obligations are identified. These services are cross subsidised for the common good of the community.

All of the proposed fees and charges are based on continuing the existing fees of the former Cootamundra and Gundagai Shire Councils, with duplicated fees being removed. Where the two former Councils had different charging systems, a choice has been made to keep one of the fees. In most cases, the simplest fee structure has been retained. Council applied a 3% increase to last years fees, adjusted for rounding, with some exceptions. Some fees are regulated, and Council charges the regulated amount. In some cases, Council has reviewed the cost of providing the service, and the fees have been increased or decreased to ensure parity between revenue and cost of service delivery.
