**COMPANION ANIMAL AUDIT** - Council will be undertaking an audit of the NSW Companion Animal Register of cats and dogs over the coming 8-10 weeks. Microchip Identification and Lifetime Registration greatly assist the Council in returning your pet in the event they are lost, hurt or stolen. Under the NSW Companion Animals Act 1998, cat and dog owners must undertake **two steps** to provide their pet with lifetime protection: Permanent Microchip Identification and Lifetime Registration. In NSW, all cats and dogs, **must** be registered by **6 months** of age, this includes all working dogs. The Registration fee is a one off payment, which is **paid at Council Offices** and this covers your pet for its lifetime, regardless of any changes in ownership. The 2019/20 Registration Fees can be viewed on Council website at <u>https://www.cgrc.nsw.gov.au/your-services/regulatory/legislation-fees/.</u> If you have sold or given away your pet, you are still responsible for changing the details into the new owner's name, and until that happens you are responsible for the animal. If your cat or dog has died, you must also notify the Council within 28 days of its death. For any enquires regarding the upcoming audit, please contact Council on 1300 459 689.


