OLYMPIC HIGHWAY "GAP" REHABILITATION PROJECT- CGRC wishes to advise work will recommence on road rehabilitation works at Olympic Highway "GAP" on Monday 8 February and should be completed on Saturday 13 February, weather permitting. Rescheduling due to wet weather forecast. Works will start at the Cootamundry Creek Bridge and finish at the Campbell Street Intersection with Sutton Street. Work commences at 7am and finishes at approximately 5pm each day except for Saturday where works should be completed by 11am. Works will involve road stabilisation, grading, compaction, and bitumen sealing. Line marking will be completed following these works. Traffic movements will be under full traffic control with reduced speed limits and single lane closure only, with priority given to local residents when possible, ensuring safety of road users. residents, and workers at all times. The Back Brawlin Road intersection with Olympic Highway may be affected by turning traffic only. Short delays only may be experienced. WEED MANAGEMENT - Weeds are everybody's responsibility. We can all work together to protect our LGA and the unique bushland, swamps and waterways of the LGA. Council's obligation. Weeds are plants that do not occur naturally in the bush. They compete with native plants and often dominate or replace them. They degrade and destroy the habitat of our native animals. Under the Biosecurity Act 2015 CGRC as the Local Control Authority has a legal obligation to manage the biosecurity risk posed or likely to be posed to human health, the economy, community, and environment by Priority Weeds. Council meets these obligations through programs to: Control Priority Weeds on Council managed land. Inspect private lands to ensure owners of land carry out their obligations. Council's Biosecurity Regulatory Officers take a co-ordinated approach working with residents, community groups and other agencies. Your obligation. Under the Biosecurity Act 2015, all landowners or land managers have a 'General Biosecurity Duty' to prevent, eliminate or minimise the Biosecurity Risk posed or likely to be posed by Priority Weeds.
