PUBLIC WORKS - Works are continuing on the Old Gundagai Road reconstruction project. Current works have seen the existing pavement reshaped and levelled in readiness for stabilisation, which is expected to commence the week of the 15 June. This project is being funded form the Roads To Recovery Program. Council's kerb contractor has commenced work on the replacement of kerb and gutter in Hay Street between O'Donnell and Adams Streets, Cootamundra. The existing kerb in this area was prioritised due to its deteriorated condition. Once this section has been completed, the section along Adams Street from Hay Street to Merle Avenue, Cootamundra will be replaced. Council's works crews are continuing with the private development work on the Cootamundra's Boundary Road Sub-division. Current works 0 involve the laying of underground sewer and stormwater drainage.
