4. TERMS AND CONDITIONS

1. Council requires 24 hours notice upon receipt of application before key is activated for use.
2. To avoid contamination, Council requests there must be an 'air gap' between the hose and tank to avoid any contamination and/or backflow into the filling station.
3. A refundable deposit of \$60.25 shall be paid on application which covers the cost of replacement keys/tags. This shall be refunded on return of both.
4. All water used will be billed.
5. Accounts to be paid within 30 days or access to standpipe will be suspended
6. Connection is to be via hose with 50mm Female camlock fitting to be supplied by the user/applicant. The hose should connect to external fitting onto your tank which is accessible from the ground.

Due to water pressure, loose hose ends could produce hose whipping which may cause injury/damage. Please ensure hose end is secured to your tank to reduce this risk. Council accepts no responsibility for damage or injury to any person when using this filling station. All due safety measures must be taken to ensure no incidents.

7. Any damage to the filling station will be the liability of the user. User details are recorded each time the station is used.
8. Use of the filling stations is via key access control panel and the activation with electronic tag. The user should monitor the flow to ascertain the volume being supplied. Flow rates can't be regulated, only 'Stop and Start'
9. At the end of filling disconnect/remove filling hose from tank and discharge excess water into the kerb and then disconnect from standpipe.
10. The applicant is, by way of signature to the application, responsible for compliance with this agreement consent conditions and is likewise responsible for compliance in respect of all agents, sub-contractors and anyone else carrying out part or all of the activity authorized under the consent as if they were the applicant.
11. All water carters should be aware of the requirements for water carting as stated in the NSW Guidelines for Water Carters (www.health.nsw.gov.au)
