### NOTIFICATION OF RABBIT BAITING PROGRAM -

#### STOCKINBINGAL CEMETERY:

Council in conjunction with Local Lands Services will be undertaking a rabbit baiting program at the Stockinbungal Cemetery in the coming weeks. **Between Monday 23<sup>rd</sup> October to Monday 30<sup>th</sup> October 2023**, green dyed chopped carrots containing the anticoagulant poison Pindone will be used at baiting stations within the Cemetery. Poisons pose an extreme risk to your livestock and domestic animals. Please take steps (e.g., restraint or muzzling) to make sure your animals do not have access to the baits or affected animals. The program is undertaken as per the Pesticide Control (Pindone Products) Order 2010. The pesticide is lethal to dogs and cats and if consumed can cause illness to humans. Contact your local vet or seek medical advice in the case of suspected poisoning. Should you require further information or wish to discuss the matter please contact the Council on 1300 459 689.

### NOTICE OF PROPOSED DEVELOPMENT:

Council is in receipt of a Development Application for consent to carry out proposed works at 1570 Old Cootamundra Road, Cootamundra NSW. The application has been lodged by EnviroAg Australia on behalf of Envolve Pastoral Co Pty Ltd. **Development Application DA2023/109 (Planning Portal Reference No. PAN-362874)** is seeking approval for a staged sheep feedlot (15,000 head standard sheep unit) and associated infrastructure at the abovementioned property. The subject application is Integrated Development under Schedule 1 of the Protection of Environmental Operations Act 1997 and Designated Development in accordance with the Environmental Planning and Assessment Act 1979 and Regulations made thereunder.

The development application and accompanying documentation including the Environmental Impact Statement (EIS) are available for public inspection on the NSW Government Planning Portal DA Exhibition webpage and on Council's website between **10 October 2023 and 10 November 2023**. Persons wishing to make a submission on the proposal may do so either via the NSW Planning Portal or directly to Council before the close of business on **10 November 2023**. Please note that all correspondence should be addressed to the General Manager and quoting Development Reference DA2023/109 as Council will be the consent authority for this development.

If a submission is made against the proposal, unless the Independent Planning Commission has held a public hearing, any submission made in objection to the development by making a submission, and who is dissatisfied with the determination of the consent authority to grant development consent, may appeal to the Court. If the Independent Planning Commission holds a public hearing, the Commission's determination of the application is final and not subject to appeal.
