#### **DEVELOPMENT APPLICATION**

Cootamundra-Gundagai Regional Council is in receipt of a development application and accompanying documentation for the following development. DA No: 2024/23 Land Description: Lot A-B DP327881, Lot 1 DP726068, Lot 101 DP1065978 - 34 Hovell Street, Cootamundra. Applicant: Peter Stanley Consent Authority: Cootamundra-Gundagai Regional Council: Description of Development: Demolition of buildings and structures and removal of underground fuel storage tank associated with the existing fuel depot, and remediation of contaminated site. The proposed development seeks consent for Category 1 remediation works in accordance with the State Environmental Planning Policy (Resilience and Hazards) 2021. The development application is therefore required to be exhibited in accordance with Schedule 1, Part 1, Division 2, Section 9A of the Environmental Planning and Assessment Act 1979 for a minimum of twenty-eight (28) days. The development application and accompanying documentation are available for public inspection, at the Council Administration Offices or on the NSW Planning Portal DA Exhibitions | Planning Portal -**Department of Planning Housing and Infrastructure** (nsw.gov.au) between 28th March 2024 and 26th April 2024. Any person may inspect the development application and documentation and make a written submission on the proposal quoting Council's file reference, DA No. 2024/23 until 5pm on Friday 26th April 2024. All correspondence should be addressed to the General Manager of Cootamundra-Gundagai Regional Council and the above DA Reference number shall be included on such correspondence. If a submission is made by way of objection, the reasons for the objection must be outlined in the submission. It should be noted that information included in submissions received regarding the proposal may be used in public reports and can be accessed under the Government Information (Public Access) Act (GIPA), 2009. Section 10.4 of the Environmental Planning Assessment Act, 1979 and the Local Government and the Planning Legislation

Amendment (Political Donations) Act, 2008 requires the disclosure of any reportable political donations or gifts by a person or persons who makes a relevant planning application to Council or submission on a relevant planning application to Council.

#### WEED SPRAYING
