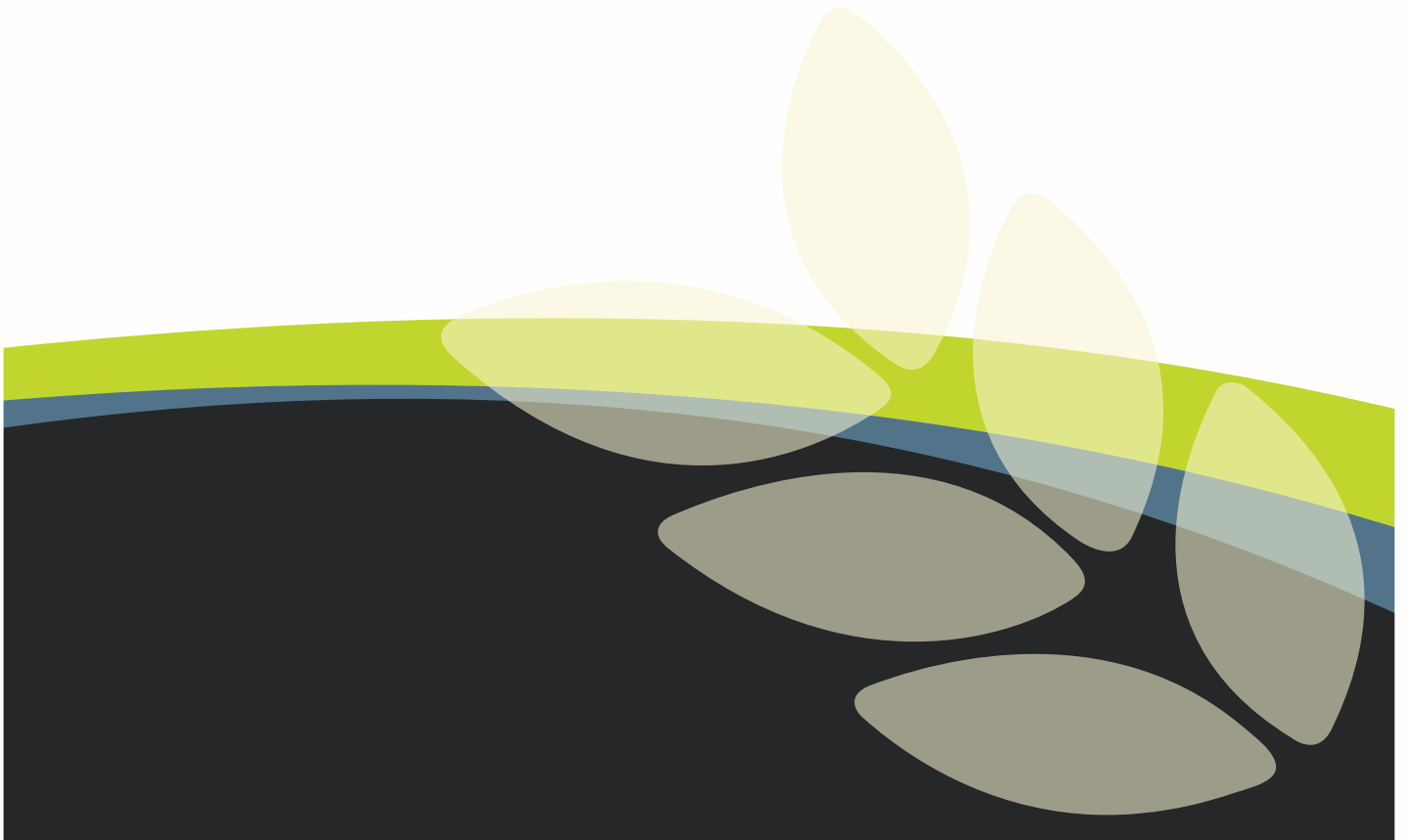

In order to provide for the expedient exercise and performance of Council's powers and duties and the efficient management of Council's business and responsibilities, under Section 377 of the *Local Government Act 1993* Cootamundra-Gundagai Regional Council hereby delegates to **The Cootamundra Showground Users Section 355 Committee** the exercise of Council's functions, which includes its powers, duties and authorities contained in legislation, and matters specified in Schedule 1, subject to the limitations specified in Schedule 2. This delegation shall remain in force until specifically altered or revoked in writing.

Undertake fundraising activities on behalf of Council, as Trustee of the Cootamundra Arts Trust, for the purpose of:

- 1) attracting and encouraging donations, gifts (by will or otherwise) endowments, trust distributions and other forms of financial assistance to or for the benefit of the Trust; and
- 2) sponsoring, organising and undertaking fund raising activities and arranging for the issue of appeals to the public for donations to the Trust.
