DE-AMALGAMATION:

OUR community has consistently told Council that they wish to de-amalgamate and move back to two separate Councils for Gundagai and Cootamundra and the NSW Government has now provided a pathway for it to happen.

TEMPORARY BUS ZONE GUNDAGAI VISITOR INFORMATION CENTRE:

THE establishment of an additional temporary bus parking zone beside the existing amenities block has been implemented for the duration of the Gundagai VIC building works. The building works are expected to be completed by August. The new parking conditions will be in place until the refurbished Visitor Information Centre is opened to the public.

COMPANION ANIMAL AUDIT:

CGRC will be undertaking an audit of the NSW Companion Animal Register of cats that are not desexed, not registered and require an annual permit. The NSW Government introduced in July 2020, annual permits for non-desexed cats as part of its commitment to promoting responsible pet ownership and improving animal welfare standards. This requires owners of non-desexed cats to pay an annual fee in addition to their one-off lifetime pet registration. The annual permit is \$92 **plus** their registration fee \$65. The registration remains a one of payment however the permit must be paid yearly. In NSW, all cats and dogs, must be registered by 6 months of age, this includes all working dogs.

Any submissions must be lodged by close of business Friday, 10 May 2024.

As the cooler weather approaches, I take this opportunity to remind residents of their obligations and responsibilities regarding backyard burning, firepits and roadside firewood collection. The collection of firewood from the regions roadsides and Travelling Stock Reserves (TSRs) is prohibited and can attract hefty fines. Anyone caught removing timber or disturbing vegetation (dead or alive) from a TSR can be fined up to \$5,500 under the Local Land Services Act 2013.AA Prohibited items, such as tyres, plastic, treated timber, paint and solvents are not to be burnt. Take into consideration alternative ways to dispose of vegetation, and the impact smoke may have on your neighbours and traffic. This includes considering the wind, weather, length of burn and material burnt. Consider what you are burning - items particularly treated pine can be

hazardous to health. Council does have the ability to regulate fir the provisions of the Clean Air Regulations (under the Protection of the Environment Operations Act, 1997) should a fire cause air pollution or contain prohibited item.
