## DISCLOSURE OF INTEREST RETURNS REGISTER FOR COUNCILLORS AND DESIGNATED PERSON

## **Overview**

Part 4 of the Model Code of conduct for Local Councils in NSW (2018) (Model Code) requires a councillor or a designated person to complete and lodge with the general manager a return disclosing his or her pecuniary interests. That return may contain personal information about each councillor and designated person, including his or her name, address and signature, as well as information about property and share holdings, gifts received, debts owed, other sources of income, and positions held in a trade union or business or professional organisation.

The mandatory pro-active release associated with the Government Information (Public Access) (GIPA) Act 2009, is requiring that the information contained in these returns should be made easily accessible, such as available free on the internet; unless:

- It imposes unreasonable costs, or
- Council determined there was an overriding public interest against disclosing information.

## Overriding public interest against disclosure

As such, council has determined that providing this information online would increase the risk associated with cybercrime activities. The following overriding public interest against disclosing has been identified, as set out in section 14 of the Gipa Act;

Table 3

Individual rights, judicial processes and natural justice.

There is a public interest consideration against disclosure of information if disclosure of the information could be reasonably expected to have one or more of the following effects:

- (a) reveal an individual's personal information.
- (f) expose a person to risk of serious harm or serious intimidation.

## Register
